IN 2023, WE STUDIED A NUMBER OF APPROACHES FOR DE-MEDICALIZED ABORTION AND SELF-CARE APPROACHES THAT PRIORITIZE A PERSON'S AUTONOMY AND REDUCES THE NUMBER OF IN-CLINIC VISITS. WE CONFIRMED THE FEASIBILITY OF TELEMEDICINE MA SERVICES IN MEXICO, UZBEKISTAN, AZERBAIJAN, AND UKRAINE.
